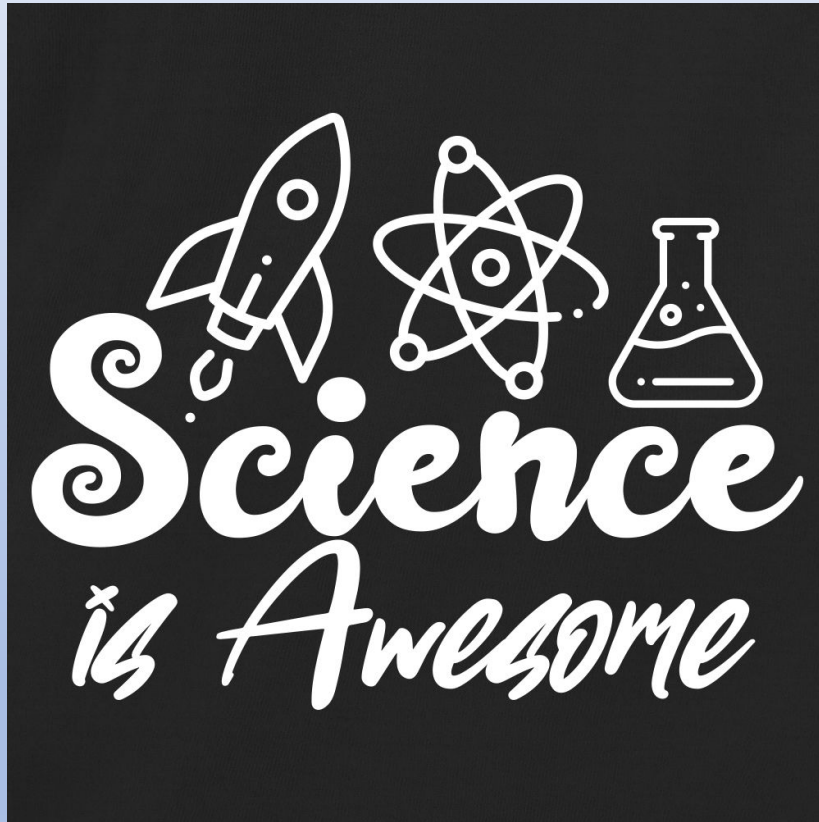



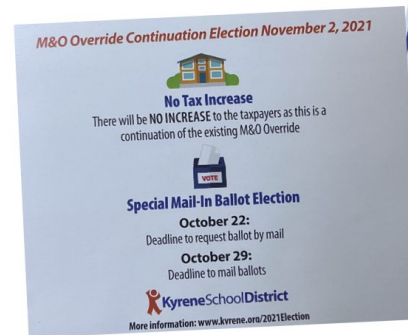


Parent Superintendent Council

Last meeting we went over How the Governing Board works:

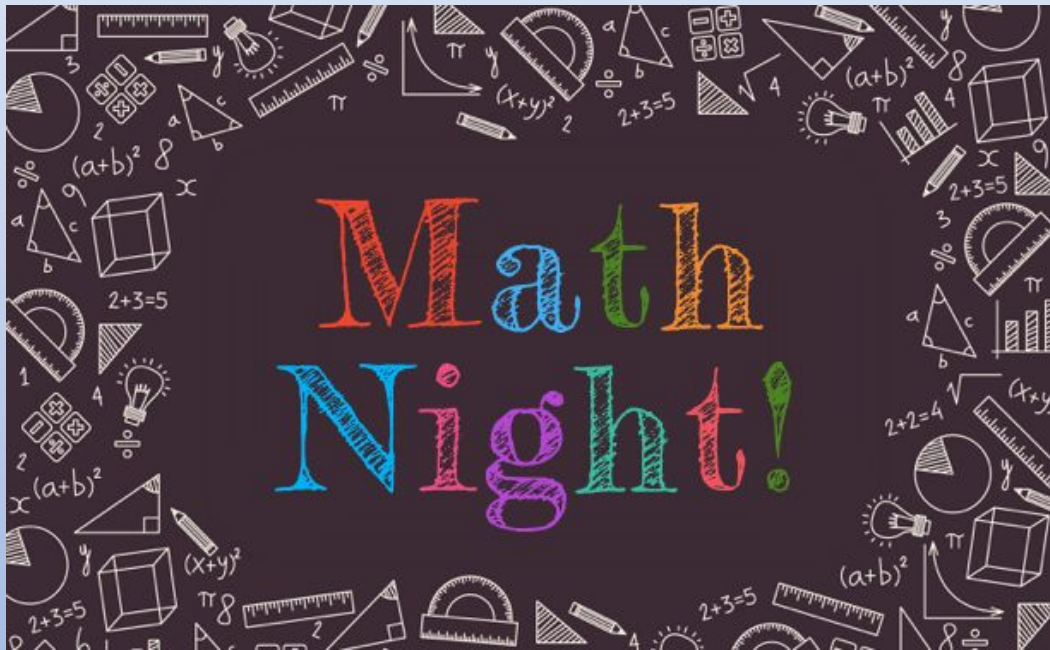
- ARS title 15 (15-341 and 15-342)
